#### ITEM 1. SECURITY AND ISSUER

This Amendment No. 2 is filed with respect to the shares of Common Stock, par value \$1.00 per share (the "Shares"), of CSX Corporation (the "Issuer"), beneficially owned by the Reporting Persons (as defined in the Schedule 13D filed with the Securities and Exchange Commission on December 19, 2007, as heretofore amended (the "Schedule 13D")) as of January 25, 2008 and amends and supplements the Schedule 13D. Except as set forth herein, the Schedule 13D is unmodified.

#### ITEM 4. PURPOSE OF TRANSACTION

Item 4 of the Schedule 13D is amended and restated to include the following final paragraph:

On January 25, 2008, the TCI Reporting Persons submitted a second supplemental notice (the "Second Supplemental Notice") to the Board (as defined in the Schedule 13D) stating their intent to present a proposal to repeal any amendment, repeal or modification that is made by the Board to the Bylaws (as defined in the Schedule 13D) from and after January 1, 2008 and prior to and including the date of the Annual Meeting (as defined in the Schedule 13D). The Second Supplemental Notice additionally makes revisions to the specific text of resolution and Bylaw amendments included as part of the Proposal (as defined in the Schedule 13D).
