Each of Seletar and Temasek Capital may be deemed to beneficially own the 8,012,821 shares of Issuer's Class A common stock beneficially owned by Aranda. Havelock Fund Investments Pte. Ltd. ("Havelock") directly owns 12,317,682 shares of Issuer's Class A common stock. (1) Havelock is wholly owned by Fullerton Fund Investments Pte. Ltd. ("FFI"). FFI may be deemed to beneficially own the shares beneficially owned by Havelock. Each of Temasek Capital and FFI are wholly owned by Temasek Holdings (Private) Ltd ("Temasek"). Therefore, Temasek may be deemed to beneficially own the 20,330,503 shares of Issuer's Class A common stock deemed to be beneficially owned in the aggregate by Temasek Capital and FFI.
