TELECOM ITALIA CONFIRMED FOR THE TENTH YEAR IN THE DOW JONES SUSTAINABILITY INDEXES

*Rome, 12 September 2013*

Following the annual review of the Dow Jones Sustainability Indexes (DJSI) Telecom Italia has been included for the tenth year in both the DJSI World and the DJSI Europe.

Inclusion in the DJSI depends on a rigorous assessment by specialised rating agencies that analyze financial and non-financial performances on the basis of general and sector criteria, including relations with customers, innovation and research, risk management, strategies relating to climate change, supply chain and social/environmental impacts of business.

The presence of a company in the sustainability indexes is particularly appreciated by investors who with increasing frequency also take into account non-financial parameters in their portfolio choices, believing that sustainable companies bear less risk, in the mid-long term, compared to companies that do not meet environmental, social and governance requirements.

Telecom Italia's score is 93/100, improved on last year, only one point lower than the sector best in class, Korean Telecom.

Inclusion in the DJSI is an important acknowledgement of Telecom Italia's social and environmental commitment, of its contribution to research and to the growth in Italy and South America, as well as of its transparency to stakeholders.

8. the impact of regulatory decisions and changes in the regulatory environment in Italy and other countries in which we operate, including recent changes to allowable charges for data and voice roaming;
9. the impact of economic development generally on our international business and on our foreign investments and capital expenditures;
10. as our services are technology-intensive, our ability to develop new technologies in order to avoid our services becoming non-competitive;
11. the impact of political developments in Italy and other countries in which we operate;
