(1) HARBINGER CAPITAL PARTNERS MASTER FUND I, LTD. (THE " MASTER FUND"). ALL OTHER REPORTING PERSONS ARE INCLUDED WITHIN THIS REPORT DUE TO THEIR AFFILIATION WITH THE MASTER FUND.

(2) These securities reported herein (the "Shares") are owned by the Master Fund, which is a Reporting Person.

These Shares may be deemed to be indirectly beneficially owned by the following, each of whom is a Reporting Person: Harbinger Capital Partners LLC ("Harbinger LLC"), the investment manager of the Master Fund; Harbinger Holdings, LLC ("Harbinger Holdings"), the managing member of Harbinger LLC; and Philip Falcone, the managing member of Harbinger Holdings and the portfolio manager of the Master Fund.

(3) Each Reporting Person listed in Footnote 3 disclaims beneficial ownership of the Shares except to the extent of his or its pecuniary interest therein, and this report shall not be deemed an admission that such Reporting Person is the beneficial owner of the Shares for purposes of Section 16 of the Securities Exchange Act of 1934, as amended, or for any other purpose.

(4) On May 1, 2009 the operating agreement of Harbinger Capital Partners NY, LLC (formerly Firebrand/Harbinger, LLC) ("Harbinger NY") was terminated, except for certain provisions, principally those regarding the distribution of investment proceeds. Since that time all of the Shares held by Harbinger NY have been distributed, or are subject to distribution, to the Master Fund (the only member of Harbinger NY with a beneficial interest in such Shares). Following such termination, Firebrand Investments, LLC, Scott Galloway and Harbinger NY have each ceased to be the beneficial owner of any of the Shares. In addition, as a result of previously reported dispositions, Harbinger Capital Partners Special Situations Fund, L.P. and Harbinger Capital Partners Special Situations GP, LLC have each ceased to be the beneficial owner of any of the Shares.

The Reporting Person disclaims beneficial ownership of any securities deemed to be owned by the group that are not directly owned by the Reporting Person.
